#### AMENDING RULE 1 OF THE RULES OF THE ONONDAGA COUNTY LEGISLATURE CHANGING THE DATE OF REGULAR SESSION TO THE FOLLOWING THURSDAY WHEN SUCH TUESDAY IS ELECTION DAY

WHEREAS, Rule 1 of the Rules of the Onondaga County Legislature provides that the date of a regular session may be changed by a motion duly passed by a majority of the whole number of the County Legislature, and it is the desire of this Legislature to change the date of the regular session occurring on the following Thursday, when such Tuesday is Election Day; and

WHEREAS, Rule 35 of the Rules of the Onondaga County Legislature also allows for the rules to be altered and amended by a majority vote of the Legislators present; now, therefore be it

RESOLVED, Rule 1 of the Rules of the Onondaga County Legislature, is amended to state:

Regular Sessions of the County Legislature shall be held on the first Tuesday of each month at 1:00 p.m. except when such Tuesday shall fall on the Legal Holiday, in which case the Session shall be held on the next following business day, or when such Tuesday is Election Day, the Session shall be held on the Thursday following. The date or time of regular Session may be changed in the same manner as the scheduling of a special session pursuant to Rule 2, or by a motion duly passed by a majority of the whole number of the County Legislature. Each regular session and all adjourned regular sessions shall be open for the consideration of any matter which may properly be brought to the attention of the County Legislature.
