Forensic Pathology Contract Services

PURPOSE:

Due to a pathologist vacancy that was budgeted to be filled in the 2023 personnel (101) line, the Medical Examiner's Office (MEO) is requesting approval to transfer funds to support contract forensic pathology services.

OBJECTIVES:

Forensic Pathology Contract Services:

The MEO's office has always relied on contracted pathologists to provide necessary coverage for the County's medical examiner services. The 2023 budget included both pathologists employed on contract as well as three full-time county employed pathologists on the personnel/101 line. However, in late 2022 and since the beginning of this year, there have only been two pathologists on staff.

A budget transfer of \$250,000 from MEO salary line will ensure adequate coverage throughout 2023. On average, the cost per day for a contracted pathologist is \$3,600. Coverage is typically provided for weekends and scheduled or out-of-office periods. Contracts include a base amount for coverage on call and fees per pathological service (autopsy, external examination, scene visit callout, death certificate only review, case review/report completion where there is no exam).

CALLING FOR PUBLICATION OF THE NOTICE OF EIGHT-YEAR REVIEW OF AGRICULTURAL DISTRICT NO. 4, TOWNS OF DEWITT, FABIUS, LAFAYETTE, ONONDAGA, POMPEY, AND TULLY IN ONONDAGA COUNTY

WHEREAS, the Onondaga County Legislature has been requested by the County's Agriculture and Farmland Protection Board to begin its eight-year review of Agricultural District No. 4 in the Towns of DeWitt, Fabius, LaFayette, Onondaga, Pompey, and Tully; and

WHEREAS, Agricultural District No. 4 was renewed in 2016 with additions in 2017, 2018, and 2022; and

WHEREAS, pursuant to Article 25AA of the Agriculture and Markets Law of the State of New York, the County Legislature must publish a notice of eight-year review as part of the Agricultural District review process; now, therefore it be

RESOLVED, that the Clerk of the Onondaga County Legislature is hereby authorized to cause to be published a Notice of Eight-Year Review of Agricultural District No. 4, Towns of DeWitt, Fabius, LaFayette, Onondaga, Pompey, and Tully, County of Onondaga, New York.



DEPARTMENT ONONDAGA COUNTY DEPARTMENT OF PLANNING PROGRAM AND FINANCIAL INFORMATION SHEET

PURPOSE:

This resolution initiates the 8-year renewal process for New York State Agricultural District #4 in the Towns of DeWitt, Fabius, LaFayette, Onondaga, Pompey, and Tully. The resolution calls for publication of notice that the County Legislature has begun its 8-year review of the district.

OBJECTIVE/ WORK PLAN:

New York's Agricultural Districts Law, Article 25-AA PDF of the NYS Agriculture and Markets Law, was enacted in 1971 to help keep farmland in agricultural production. Agricultural districts are designed to protect agriculture through a combination of landowner incentives and protections that discourage the conversion of farmland to non-agricultural uses.

Responsibility for the creation, review and management of the State's agricultural districts lies within the authority of the county's legislative bodies. AML Sections 303 (district creation), 303-a (district review), 303-b (annual inclusion of lands) and 303-c (district consolidation) detail the role county agricultural and farmland protection boards and legislative bodies play in district creation and review and prescribe the public notice and public hearing requirements.

Per AML Section 303-a, the county legislative body is responsible for conducting a review and renewal of each agricultural district in the county on an eight-year schedule. During the renewal period, landowners and municipalities can request to have property added to or removed from the district, usually January 1-30, to align with the annual open enrollment process for all districts in the County.

A report is then prepared by the Onondaga County Agriculture & Farmland Protection Board and presented to the County Legislature. The County Legislature reviews the plan, holds a public hearing, and determines if the the district should be continued, terminated, or modified; and then submits the final plan and required documentation to the Commissioner of Agriculture & Markets for certification.

Agricultural District #4 in the Towns of DeWitt, Fabius, LaFayette, Onondaga, Pompey, and Tully currently has approximately 63,090 acres enrolled in the program.

Article 25AA of the Agriculture and Markets Law of the State of New York. The Onondaga County

Legislature may recommend that the New York State Department of Agriculture and Markets modify,

terminate, or continue said district for a period of eight years after conducting this review.

Said district encompasses approximately 63,090 acres and includes land within the Towns of DeWitt,

Fabius, LaFayette (east of Route 81), Onondaga (east of Route 81), Pompey, and Tully (generally

east of Route 81). An official map and description of said district will be on file and open to public

inspection in the office of the Clerk of the Onondaga County Legislature, Onondaga County Court House,

Room 407, 401 Montgomery Street, Syracuse, New York, 13202. An unofficial map can also be viewed

on the Onondaga County Department of Planning's website at http://ongov.net/planning/review.html

PLEASE TAKE FURTHER NOTICE that any municipality or landowner within said district may propose

a modification (parcel additions or removals) of said district. Any proposed modification should be filed

with the Onondaga County Department of Planning, on behalf of the Clerk of the Onondaga County

Legislature, at 335 Montgomery Street, Syracuse, New York, 13202 on or before January 30, 2024.

Descriptions:

- 1. <u>Onondaga County Greenway Plan</u> The funding will provide consulting assistance with plan development, resource inventories, stakeholder engagement, and document/website development.
- 2. <u>CNY Regional Market Strategic Revitalization Plan</u> A strategic plan for revitalization of the facility, which is an important resource within the Ley Creek and Onondaga Lake greenway systems and supporting rural greenspaces.
- 3. <u>Greenway Implementation Projects</u> To provide match for grants and support projects identified in the Onondaga County Greenway Plan.
- 4. <u>Blueway Plan and Projects</u> To provide funding for the plan and match for grants and support projects identified in the Onondaga County Blueway Plan.
- 5. <u>Inner Harbor Implementation Projects</u> To fund projects consistent with the Lakefront Local Waterfront Revitalization Program plan.
- 6. <u>Otisco Lake Drinking Water Source Protection Plan Implementation</u> This funding will be used to support the plan, and efforts to protect Otisco Lake.
- 7. West Shore Onondaga Lake Park and Amphitheater Bypass Trail This study will examine and create an actionable plan for improvements to the west shore of Onondaga Lake including among other things a multi-use Amphitheater Bypass Trail to be used during amphitheater events.
- 8. <u>Split Rock Recreation Area and Onondaga Greenway Multi-Use Trail</u> (Kasson to Onondaga Road along former Trolley Line to City of Syracuse along Onondaga Road) This study will create a comprehensive approach to recreation and conservation in the area around Split Rock, an immensely popular recreation resource in the Town of Onondaga and Camillus. This includes the feasibility of necessary improvements to formalize a trail to create the Onondaga Greenway Multi-Use Trail.
- 9. Skytop Recreation Area and Solar Commercial Park This project will study the feasibility of uniting various interests and formalizing this recreation hotspot in the towns of Onondaga and Dewitt. At the same time the study will examine the feasibility of a solar installation and commercial development where feasible on the site to recoup costs of providing and formalizing recreational resources.
- 10. <u>Skaneateles/Jordan/Elbridge Trail</u> This feasibility study will examine the extension of the Charlie Major Trail in Skaneateles and the unofficial Valley Road trail in Elbridge to create a multi-use trail connecting Skaneateles, Elbridge, Jordan and the Empire State Trail.
- 11. <u>Salina Bear Trap Creek Trail Extension to Park Street</u> This study will examine the feasibility of extending the Bear Trap Creek Trail in Salina south from 7th North Street to Park Street in Syracuse. The study will also consider extending the trail north toward Airport Boulevard and East Taft Road in the Town of Cicero.
- 12. <u>Bike Park Flow Trail Grant</u> These funds are to provide funding to locate, design and build a mountain bike flow trail within Onondaga County.
- 13. <u>Bear Trap Creek Trail Pavement Repair Grant</u> These funds will provide assistance in repairing the pavement on Bear Trap Creek Trail in the Town of Salina. The trail has been damaged by tree roots which is not uncommon.

RESOLVED, that Rule 3, items 2, 4, 5, and 6, of the Rules of the Onondaga County Legislature are hereby amended to read as follows:

- 2. Approval of the minutes of the proceedings of the previous session.
- 4. Reports of Standing Committees (if applicable).
- 5. Reports of Special Committees (*if applicable*).
- 6. Calling the respective legislative districts for the presentation of petitions and resolutions. Provided, however, that the Clerk shall rotate on a monthly basis the order of calling the respective legislative districts for the presentation of resolutions and petitions by calling a different district each month to be the first and last to present resolutions and petitions, commencing in the first month of the term by calling district one first and district seventeen last, and proceeding consecutively each month to call successive districts first and last; except for the Session adopting the annual County budget, which shall commence with the district of the sponsor of the resolution adopting the annual County budget.

RESOLVED, this resolution shall take effect immediately.

CHANGES TO THE RULES

The following changes will streamline session and committee meetings.

Rule 3 (2) & Rule 39a (1): Removing the word "Reading"

The order of business does not have to include reading of the minutes prior to approval of minutes. If this change is approved, the Chair will only ask for corrections and approve the minutes moving forward. In regard to the committee meeting, the verbiage "of the proceedings" was removed because it is unnecessary.

Rule 3 (4 &5): Adding "(if applicable)"

Historically during session, the Legislature has not had reports of standing or special committees in a very long time. By adding this verbiage, it will only be added to a session agenda if in fact there are reports to be listed.

Rule 3 (6): Adding verbiage regarding district order

This is to reduce confusion and help administrative staff with the agenda for the session where there annual budget is considered. Historically, the Legislature always takes the budget resolution first, as most other resolutions voted on during that session are a result of the budget. Because of this, adding the verbiage below would allow for the budget session agenda to be in district order starting with the sponsor's district (sponsor of the budget resolution).

RULE 3. The Order of business at each day's Session, except at such times as may be set apart for the consideration of special orders of the day, shall be as follows:

- 1. Calling the roll of members by the Clerk.
- 2. Reading and Approval of the minutes of the proceedings of the previous session.
- 3. Presentation of Communications.
 - a. Chairperson's Remarks.
 - b. Public Comment.
- 4. Reports of Standing Committees (*if applicable*).
- 5. Reports of Special Committees (*if applicable*).
- 6. Calling the respective legislative districts for the presentation of petitions and resolutions. Provided, however, that the Clerk shall rotate on a monthly basis the order of calling the respective legislative districts for the presentation of resolutions and petitions by calling a different district each month to be the first and last to present resolutions and petitions, commencing in the first month of the term by calling district one first and district seventeen last, and proceeding consecutively each month to call successive districts first and last; except for the Session adopting the annual County budget, which shall commence with the district of the sponsor of the resolution adopting the annual County budget.

RULE 39a. The order of business at each meeting of a standing committee of the legislature shall be as follows:

- 1. Reading and Approval of the minutes of the proceedings of the previous meeting.
- 2. Presentation of resolutions and local laws.
- 3. Adjournment.
