WHEREAS, it has pleased Almighty God to remove from this Earth, the Honorable James C. Tormey III, Justice of the New York State Supreme Court; and

WHEREAS, the Honorable James C. Tormey III, a Syracuse native, served as the Administrative Judge for the Fifth Judicial District of the New York State Courts from 2000 through 2019, having been appointed to serve in that position by the Chief Administrative Judge; and

WHEREAS, the Honorable James C. Tormey III served as Justice of the New York State Supreme Court, first appointed in 1995 and shortly thereafter elected to serve a fourteen-year term; and

WHEREAS, the Honorable James C. Tormey III also served as Syracuse City Court Judge, elected to that position in 1987 and serving through 1995; and

WHEREAS, the Honorable James C. Tormey III first served as an Onondaga County Legislator in 1977, then was re-elected to serve a total of five terms through 1987, where his tenure included rising to serve as Chairman of the Legislature's Health Committee; and

WHEREAS, during the Honorable James C. Tormey III's tenure as Administrative Judge for the Fifth Judicial District, Judge Tormey oversaw 300 judges and 600 court employees for nearly two decades within Herkimer, Jefferson, Lewis, Oneida, Onondaga and Oswego Counties; and

WHEREAS, as Administrative Judge for the Fifth Judicial District, the Honorable James C. Tormey III was a dedicated administrator who successfully improved the operation of the courts, instituted centralized arraignments in Onondaga and Oneida Counties, organized peer review and mentoring programs for judges, and spearheaded access-to-justice initiatives; and

WHEREAS, the Honorable James C. Tormey III proudly coached local youth in the sports of lacrosse, little league, and hockey, founded the Valley Lacrosse League in 1992, and was instrumental in the planning of a new turf lacrosse and football field in the Valley area of the City of Syracuse; and

WHEREAS, the Honorable James C. Tormey III is remembered as a devoted family man, a loyal and honorable friend, and as a man who truly cared for those he oversaw, with a deep desire to help those around him; and

Tormey III leaves behind his beloved wife Susan, beloved son Andrew, beloved daughter Colleen, and three cherished grandchildren, and it is the desire of this Legislature to express its sympathy to the grieving family of the Honorable James C. 

WHEREAS, by Notice of Violation dated December 21, 2017, the New York State Department of Environmental Conservation (DEC) informed Onondaga County that the DEC would be initiating an enforcement action against the County for violating its State Pollution Discharge Elimination System (SPDES) permit in connection with the unpermitted discharge of raw sewage to Onondaga Creek and Onondaga Lake resulting from ruptures of the Ley Creek Force Main; and

WHEREAS, the County and DEC seek to enter into an Order on Consent (Case No.: R7-20180522-22) to settle this matter, a copy of which Order on Consent is on file with the Clerk of this Legislature; and

WHEREAS, the Order on Consent provides for the County to pay the DEC the sum of \$5,300 as a payable penalty, with a \$100,000 penalty suspended pending timely and successful completion of certain compliance items set forth in the compliance schedule attached to said Order, and the Central New York Regional Planning and Development Board (CNYRPDB) \$30,000 to help fund an Environmental Benefit Project (EBP) consisting of Onondaga Watershed Investigation and Remediation Projects (e.g., Tully Valley Mud Boil Remediation, Microbial Trackdown and fish consumption advisory education and outreach); and

WHEREAS, it is in the best interests of the County to enter into said proposed Order on Consent; now, therefore be it

RESOLVED, that the County Attorney is authorized to settle said action for the sum of \$135,300, of which \$100,000 is suspended, and that the Comptroller be and hereby is authorized to draw his warrant, charging it against the proper funds; and, be it further

- 1. The New York State Department of Environmental Conservation (the Department or DEC) is responsible for the administration and enforcement of Article 17 of the New York State Environmental Conservation Law (ECL) and of Title 6 of the Official Compilation of Codes, Rules, and Regulations of the State of New York (6 NYCRR) Part 750, promulgated pursuant thereto.
- 2. The County of Onondaga (Respondent or Onondaga) is a municipal corporation organized and existing under the laws of the State of New York with municipal offices located in the City of Syracuse, Onondaga County, New York.
- 3. ECL 17-0511 provides that the use of existing or new outlets which discharge sewage is prohibited unless done in compliance with all standards, criteria, limitations, rules and regulations promulgated or applied by the Department.
- 4. ECL 17-0501 makes it unlawful, directly or indirectly, to throw, drain, run, or otherwise discharge into the waters of the State organic or inorganic matter that shall cause or contribute to a condition in contravention of the standards adopted by the Department pursuant to ECL 17-0301.

- 5. ECL 17-0803 makes it unlawful to discharge pollutants or other wastes from a point source to waters of the State without a State Pollutant Discharge Elimination System ("SPDES") permit or to discharge in a manner other than as prescribed by such permit.
- 6. Title 6 NYCRR Subpart 750-2 sets forth regulations for operating a facility with a SPDES Permit.
- 7. Onondaga owns the Metropolitan Syracuse Wastewater Treatment Plant (Facility) located at 650 Hiawatha Boulevard West, Syracuse, Onondaga County, New York.
- 8. Onondaga applied for a SPDES Discharge permit for the Facility. The Department issued the current SPDES Discharge Permit NY-0027081, effective date July 1, 2017, expiration date June 30, 2022 (Permit). The Permit, and its predecessors, allows discharges into waters known as Onondaga Creek and Onondaga Lake, a class C water.
- 9. One of the force mains that transports raw sewage from the Facility collection system to the Facility for treatment is known as the Ley Creek Force Main, a 42 inch pipe located for part of its length adjacent to train tracks. Historically that force main has conveyed sewage under pressure, transported corrosive chemicals and been subjected to hydrogen sulfide pressures. These factors coupled with the age and location of the force main have predictably caused the force main to rupture on several occasions.
- 10. The Ley Creek Force Main ruptured on July 25, 2013, October 21, 2016 and on October 30, 2017.
- 11. Each time the force mail ruptured, raw sewage did not reach the Facility for proper treatment as required by law and the Permit. Instead raw sewage discharged straight into receiving waters as follows:

- a. July 25, 2013: Raw sewage discharged into Onondaga Lake over a period of three days. During the repair at a later date, the estimated volume for additional discharge into the Lake was 6,900,000 gallons.
- b. October 21, 2016. Raw sewage discharged into Onondaga Lake immediately after the rupture and during the repair. The estimated volume discharge was 13,000,000 gallons.
- c. October 30, 2017. Raw sewage discharged into Onondaga Lake immediately after the rupture and during the repair. The estimated volume discharge was 70,000,000 gallons.
- 12. The unpermitted discharges described in paragraphs 10 and 11 of this Order violate ECL sections 17-0501, 17-0511 and 17-0803.
- 13. ECL 71-1929.1 provides for a civil penalty of up to \$37,500 per day for each violation of titles 1 through 11 and 19 of ECL Article 17 or the rules, regulations, orders, or determinations of the Commissioner promulgated thereto or the terms of any permit issued thereunder.
- 14. As settlement of the violations set forth in this Order, Respondent affirmatively waives the right to a hearing on this matter as provided by law, consents to the issuing and entering of this Order without further notice, and agrees to be bound by the provisions, terms, and conditions contained herein.

NOW, having considered this matter and being duly advised, IT IS ORDERED THAT:

I. <u>Compliance</u>. Respondents shall comply with the provisions, terms, and conditions set forth in this Order. Respondent's failure to comply with any provision of this Order shall constitute a default and a violation of this Order and, upon such default and violation, the Department's right to pursue all claims and remedies administratively, at law, or in equity shall not be affected by anything contained in this Order.

- II. <u>Schedule for Compliance</u>. Respondents shall fully comply with the Schedule for Compliance set forth as Schedule A to this Order. Respondent shall properly execute this Consent Order and return it to the "New York State Department of Environmental Conservation" mail to: The New York State Department of Environmental Conservation, Region 7, Office of General Counsel, 615 Erie Boulevard West, Syracuse, New York 13204-2400, to the attention of Joseph Sluzar, Regional Attorney.
- III. <u>Environmental Benefit Project</u>. Respondent shall participate in an Environmental Benefit Project (EBP) that complies with the Department's environmental benefit projects policy (CP 37), and shall spend Thirty Thousand and no/100 (\$30,000.00) on the EBP.

Onondaga Lake is a Class C water body of the State of New York. This proceeding was commenced following several unauthorized discharges into Onondaga Lake. In this EBP, Onondaga County will take steps to help restore Onondaga Lake and its watershed for the benefit of the public. These steps shall include the following:

- a) The Department and Central New York Regional Planning and Development Board (CNTRPB) have entered into a "Cooperative Agreement" to fund Onondaga Watershed Investigation and Remediation Projects, including Tully Valley Mud Boil Remediation, Microbial Trackdown and fish consumption advisory education and outreach (Cooperative Agreement).
- b) Respondent agrees to pay Thirty Thousand and no/100 (\$30,000.00) to CNYRPB to fund Onondaga Watershed Investigation and Remediation Projects pursuant to the described Cooperative Agreement.

- c) Within 30 days after payment of the \$30,000.00 to CNYRPB, Respondent shall submit a receipt or other proof of payment to the Department and an affidavit of completion based upon the format set forth in Commissioners Policy 37.
- d) The Department shall be the sole judge of whether Respondent has complied with the terms of this Order as it relates to satisfactory implementation of the EBP.
- e) Any statements, whether written or oral, that Respondent (or third-party at the request of the Respondent) makes with respect to the EBP shall include language stating that the project was undertaken as part of the resolution of an enforcement matter brought by the department for applicable violations.
- IV. <u>Civil Penalties</u>. For the violations set forth herein, Respondent is hereby assessed a Payable Civil Penalty of five thousand three hundred dollars (\$5,300.00). a) The civil penalty of \$5,300.00 shall be paid, by electronic payment at http://www.dec.ny.gov/about/61016.html on-Line or by check made payable to the order of the "New York State Department of Environmental Conservation," with the enclosed invoice and the Case Number of this Order on Consent written in the memo section of the check, which shall be sent to the Department of Environmental Conservation, Division of Management and Budget Services, 625 Broadway, 10th Floor, Albany, NY 12233-4900. (See Consent Order Payment Insert for additional instructions). b) Respondent is further assessed a Suspended Civil Penalty of one hundred thousand dollars (\$100,000.00), payment of which is suspended as a penalty to guaranty compliance and which shall become payable in the event that Respondent fails to comply with the provisions, terms, and conditions of this Order. The penalty to guaranty compliance under this paragraph shall become due and payable within fifteen calendar days after

Respondents receive written notice from the Department that Respondents are or were in violation of this Order. c) Failure to pay any penalty in accordance with this Article IV shall constitute a violation of this Order and may result in the assessment of additional penalties.

V. Default of Payment: The penalties assessed in this Order constitute a debt owed to the State of New York. Failure to pay the assessed penalty, or any part thereof, in accordance with the schedule contained in this Order may result in referral to the New York State Attorney General for collection of the entire amount owed (including the assessment of interest and a charge to cover the cost of collecting the debt) or referral to the New York State Department of Taxation and Finance, which may offset by the unpaid penalty amount any monies that may be owed to Respondents by the State of New York.

VI. Inspections. Respondents shall at all times allow any duly designated employee, consultant, contractor, or agent of the Department or of any other State agency to immediately enter the Facility or areas in the vicinity of the Facility which may be under the control of Respondents for purposes of inspecting and to ensure Respondents' compliance with this Order, with any permit, registration, license, or certificate heretofore or hereafter issued for the Facility, and with applicable laws and regulations.

VII. <u>Indemnification</u>. Respondents shall indemnify and hold the Department, the State of New York, and their representatives and employees harmless from all claims resulting from the acts or omissions of Respondents or their agents in compliance or attempted compliance with the provisions of this Order.

- VIII. Reservation of Rights. The Department hereby reserves all its legal, administrative, and equitable rights arising at common law or as granted to it pursuant to statute or regulation, including, but not limited to, any summary abatement powers the Commissioner may have pursuant to ECL §71-0301.
- IX. <u>Modifications</u>. No change in this Order shall be made or become effective except as specifically set forth by a further written order of the Department, being made either upon written application to the Department by Respondents setting forth the grounds for the relief sought; upon the Department's own findings after an opportunity for Respondents to be heard; or pursuant to the summary abatement powers of the Department.
- X. Regulatory Fees. Nothing contained in this Order shall be construed as preventing the Department from collecting regulatory fees, where applicable.
- XI. <u>Binding Effect</u>. The provisions, terms, and conditions of this Order shall bind Respondents, Respondents' agents, servants, employees, successors, and assigns, and all persons, firms, and corporations acting under or for Respondents.
- XII. Force Majeure. Respondents shall not be in default of compliance with this

  Order if they cannot comply with the terms of this Order because of an act of God or other such
  condition, as to which, conduct on the part of Respondents or their consultants, contractors, or
  other agents was not a cause; provided, however, that Respondents immediately notify the

  Department in writing when they obtain knowledge of any such condition and request and
  receive an appropriate extension or modification of the provisions hereof.
- XIII. <u>Approval of Plans</u>. "Approvable" within the context of this order shall mean capable of being approved by the Department with only minimal revision. Minimal revision

shall mean revised and resubmitted to the Department within fifteen days after notification by the

Department of revisions that are necessary.

XIV. Entire Order. The provisions hereof shall constitute the complete and entire

Order by the Department concerning Respondents and these violations. No terms, conditions,

understandings, or agreements purporting to modify or vary the terms of this Order shall be

binding unless approved in writing by the Commissioner or the Department's Region 7 Regional

Director. Nothing contained in this Order shall affect Respondents' responsibilities under any

other Order with the Department.

XV. <u>Affected Resources</u>. The Department reserves the right to bring any future

action, administratively, at law, or in equity, against Respondents or Respondents' directors,

officers, employees, servants, agents, successors, or assigns, regarding areas or resources which

have been or may be adversely affected as a result of Respondents' violations described in this

Order.

XVI. Effective Date. The effective date of this Order shall be the date it is signed by

the Commissioner or the Commissioner's designee.

#### Schedule A Schedule for Compliance

- Within 90 calendar days of the execution of this Order, Respondent shall provide a written plan detailing their methods for detecting and determining flow rates to the environment in the event of a break or rupture of any large capacity force main or sewer including the Ley Creek force main, Liverpool force main, Main Interceptor Sewer (MIS), and the Harbor Brook Interceptor Sewer (HBIS). The plan must include the County's existing capabilities for determining individual flow measurements, and fluctuations in flows, from each large capacity force main and sewer. The plan shall also include an evaluation of the feasibility of implementing additional measures needed (i.e. flow meters, SCADA improvements, wet weather inspections, etc.) to improve the County's ability to detect, locate, timely respond, and measure future force main and sewer failures with discharges to the environment.
- 2) Respondent shall conduct a detailed engineering evaluation of the existing Ley Creek and Liverpool force mains and make recommendations for rehabilitation and/or replacement corrective measures to eliminate and prevent recurrence the force mains failures. The Department acknowledges the Respondent's proactive efforts to implement the force main engineering evaluation as outlined in the Respondent's attached "Request for Proposal Ley Creek and Liverpool Force Mains Rehabilitation/Replacement Project" document. The Department further acknowledges the Respondent's overall goals to increase the useful life of the Ley Creek and Liverpool conveyance systems by 60 years, maintain (or increase) conveyance capacity, and construct a creek crossing independent of the CSX bridge. Consistent with the Respondent's evaluation efforts, the following compliance items will become incorporated into and made an enforceable part of this Schedule for Compliance and Order:

- a. Alternatives Analysis Technical Memorandum: By no later than June 1,2020, Respondent shall prepare and submit to Department, for review and approval, a technical memorandum describing all corrective measures and alternatives evaluated, including associated costs, logistics of implementation, advantages and disadvantages, specific recommendations, and other considerations and factors applicable. The evaluation shall consist of an assessment of existing conveyance systems conditions, field inspections of all manholes and air valves associated with the force mains, a detailed hydraulic analysis of existing force mains and interconnections, a preliminary hydraulic analysis of proposed force mains and interconnections, and an evaluation of at least three (3) alternative rehabilitation and/or replacement methods along with justification for the preferred corrective measure alternative(s).
- b. Preferred Alternative Basis of Design Report and 25% Design: By no later than December 31, 2020, Respondent shall prepare and submit to Department, for review and approval, a Basis of Design Report along with 25% Design documents for the preferred corrective measure alternative. The submission shall include detailed hydraulic analysis of the proposed force mains along with conveyance capacities and efficiencies, and preliminary details of the preferred alternative, not limited to, the review of existing information, site inspections, acquisition of topographic surveys, soil and subsurface investigations, outline of design specifications, layouts of existing and new force main alignments, identification of any needed property easements or permits including SEQR process, a general bypass pumping plan, and a preliminary cost estimate. The submission shall include a summary of all work activities competed and a conceptual schedule of future activities.
